SENATE RULES COMMITTEE MINUTES

June 23, 2010

The Senate Rules Committee met at 9:00 AM on Wednesday, June 23, 2010 in Room 414 of the Legislative Office Building. There were 14 Members of the Committee in attendance. Senator David Hoyle, Chairman of the Committee, called the meeting to order. He recognized the following Pages: Katelyn Stiles, Sierra Croft, Andrew Harris and Taylor Mahaffey all from Gastonia, North Carolina and sponsored by Senator David Hoyle. Brandon Hughes from Garner, North Carolina, sponsored by Senator David Rouser, Davis Mitchell from Cary, North Carolina, sponsored by Senator Josh Stein and Jennifer Volveno from Cary, sponsored by Senator Jean Preston.

**HB 1307 – Possess Prescription Drug/Not Drug Traffick** – Senator Dan Clodfelter moved to adopt a Proposed Committee Substitute Bill which changes the Short Title of the Bill to: **No Felon as Sheriff**, motion approved. After discussion by the Committee, Senator Fletcher Hartsell moved go give the new PCS a “favorable” report, motion passed.

**HB 1840 – Remove Sunset/e-NC Authority** – Senator A. B. Swindell moved to adopt a Proposed Committee Substitute Bill which changes the Short Title of the Bill to: **Remove e-NC Sunset/Study Competing Systems**. motion approved. After discussion by the Committee, Senator Stan Bingham moved to give the new PCS a “favorable” report, motion passed.

Senator Hoyle turned the Meeting over to Senator A. B. Swindell to Chair the Committee as he came to explain S. B. 35 which had been thoroughly discussed at the previous Senate Rules Committee Meeting.

**SB 35 – Reconveyance Fees Prohibited** – Senator David Hoyle came to explain SB 35 which was originally **Early Organizational Session** and was thoroughly discussed at the previous Senate Rules Committee Meeting on June 15, 2010. After the discussion, Senator Richard Stevens made a motion to “concur” with the House of Representatives on this Bill, motion passed.
