

Instructions for Filing
LIMITED LIABILITY COMPANY
ARTICLES OF RESTATEMENT
(Form L-16)

- Item 1** Enter the complete company name exactly as it appears in the records of the North Carolina Secretary of State.
- Item 2** Attach the text of the restated or amended and restated Articles of Organization to the Articles of Restatement.
- Item 3** Select the applicable choice with regard to whether or not the text of the restated Articles of Organization contains an amendment and if so, how the amendment or amendments were approved.
- Item 4** Enter the name of the current registered agent and the physical and mailing address of the current registered agent's office of the limited liability company in the space provided.
- Item 5** The document will be effective on the date and time of filing, unless a delayed date or an effective time (on the day of filing) is specified. If a delayed date is specified without a time, it will be effective at 11:59 p.m. Raleigh, North Carolina time on the day specified. If a delayed effective date is specified with a time, the document will be effective on the day and at the time specified. A delayed effective date may be specified up to and including the 90th day after the time of filing.

- The name of the limited liability company as it appears in Item 1.
- The signature of the representative of the limited liability company executing the document.
- The name and title of the above-signed representative.
